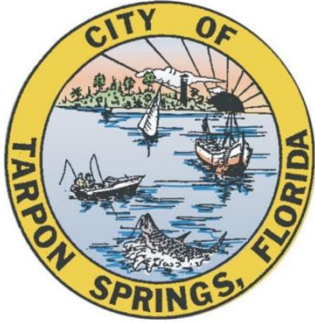

SUBJECT: PUBLIC HEARING PROCEDURES FOR THE ADOPTION OF THE
TENTATIVE BUDGET FOR FISCAL YEAR 2025-2026.

RECOMMENDATION:

To adopt Resolution 2025-01 tentatively adopting the budget for Fiscal Year 2025-2026.

BACKGROUND:

The procedures for the adoption of the budget for Fiscal Year 2025-2026 are set forth in 200.065, Florida Statutes.

Briefly stated, the procedures which must be followed by the CRA at the public hearing are as follows:

1. Amendment of the tentative budget.
2. Reading in full of the Resolution adopting the tentative budget.
3. Motion adopting the Resolution of the tentative budget.

RESOLUTION 2025-01

A RESOLUTION OF THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF TARPON SPRINGS, FLORIDA, TENTATIVELY ADOPTING THE BUDGET FOR FISCAL YEAR 2025-2026.

WHEREAS, a public hearing was held on September 3, 2025 at 6:30 p.m. to adopt a tentative budget.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF TARPON SPRINGS, FLORIDA, that:

SECTION 1. The Community Redevelopment Agency's annual budget for Fiscal Year 2025-2026 is hereby tentatively adopted.

SECTION 2. The City staff is hereby directed to notify all pertinent governmental agencies of the provisions hereof, as required by law.
