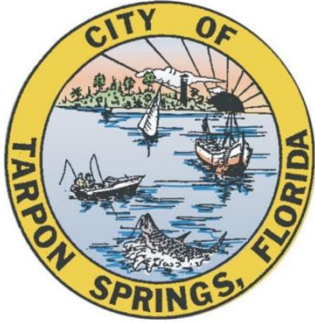

SUBJECT: PUBLIC HEARING PROCEDURES FOR THE ADOPTION OF THE
FINAL BUDGET FOR FISCAL YEAR 2025-2026.

RECOMMENDATION:

To adopt Resolution 2025-02 adopting the final budget for Fiscal Year 2025-2026.

BACKGROUND:

The procedures for the adoption of the budget for Fiscal Year 2025-2026 are set forth in 200.065, Florida Statutes.

Briefly stated, the procedures which must be followed by the CRA at the public hearing are as follows:

1. Amendment of the final budget.
2. Reading in full of the Resolution adopting the final budget.
3. Motion adopting the Resolution of the final budget.

RESOLUTION 2025-02

A RESOLUTION OF THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF TARPON SPRINGS, FLORIDA, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2025-2026.

WHEREAS, a public hearing was held on September 17, 2025 at 6:30 p.m. to adopt a final budget.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF TARPON SPRINGS, FLORIDA, that:

SECTION 1. The Community Redevelopment Agency's annual budget for Fiscal Year 2025-2026 is hereby finally adopted.

SECTION 2. The City staff is hereby directed to notify all pertinent governmental agencies of the provisions hereof, as required by law.

SECTION 3. This Resolution shall become effective October 1, 2025.
